# ABCC Secures \$2.23M Grant from KS Children's Cabinet Child Care Capacity Accelerator Grant

The Kansas Children's Cabinet and Trust Fund has announced the approval of an impressive \$43,593,294 in grant funding awards, benefiting 52 organizations

and partnerships across
the state. Among the top
recipients, Advancing
Barton County
Childcare (ABCC)
proudly ranks in the
elite top 4 awards for
Kansas communities,
receiving a substantial

grant of \$2,238,630. This remarkable achievement propels ABCC's mission to establish affordable and accessible childcare facilities within Barton County.

ABCC's aims to address the escalating demand for childcare capacity within our community, while also catering to the workforce needs of the region.

Spearheaded by Great Bend Economic Development (GBED), ABCC has assumed

the crucial responsibility of securing funding and constructing cuttingedge group daycare centers in Barton

County. With the pressing demand

for reliable and accessible

childcare services in mind,
this significant grant will
propel ABCC forward in
realizing their vision of
establishing the first two
premier daycare centers
in Barton County.

The first facility, which will be located at Farmer's Plaza on the corner of 10th Street and K-96 Highway, is now fully funded, thanks to this substantial grant. ABCC will mark this momentous milestone with a groundbreaking ceremony scheduled for July 20th at 10 am. The event promises to be a moment of celebration and anticipation, as ABCC unveils exciting developments surrounding their endeavor.

The Accelerator Grant, awarded by the

Kansas Children's Cabinet and Trust
Fund, will enable ABCC to collaborate
with community-based teams, including
early childhood providers, champions,
employers, and economic development
leaders. Together, they will forge ahead in
their collective efforts to create affordable
and accessible childcare seats throughout
the region.



## **Loft Grant Awarded to The Zarah Project**

Representatives of MyTown LP, namely Mark Bitter, Sheryl Cheely, and Mark Mingenback, were presented with a check worth \$265,650 by Great Bend Economic Development on Wednesday, June 7th. This check was awarded to MyTown LP as they were selected as recipients of the Loft Grant. The Loft Grant program aims to support property owners in revitalizing the upper levels

of buildings located in Great Bend's downtown area. Mark Bitter expressed that upon completion of the project, there will be a total of 24 new residential units available.

MyTown LP had acquired the Zarah building, situated on the southeast corner of the intersection between Lakin Avenue and Main Street, back in 2008. In collaboration with the Loft Grant and a

financial assistance of \$1.425 million received from the Kansas Housing Resources Corporation, the investors of MyTown LP are undertaking a substantial project valued at approximately \$6 million. The objective is to transform the previously vacant upper floors of the building into studio, one-bedroom, and two-bedroom apartments, targeting individuals or families with moderate incomes.

GBED remains committed to promoting economic growth and community development. Through initiatives like the Loft Grant and the new incentive program, GBED strives to create a vibrant and thriving environment for residents, businesses, and visitors in Barton County.

Barton Community College has partnered with Medicalodges, Inc. to launch the Medicalodges Academy: Pathway to Learning and Earning, an apprenticeship program that combines classroom instruction with paid on-the-job training. The program offers training in various healthcare fields such as nursing and dietary management. Barton Community College aims to support workforce development by providing on-the-job training, technical instruction, and industry-recognized credentials through apprenticeship programs. # GBED launches BC ReNEW, a Housing Rehab Program for Barton County Homeowners

Great Bend Economic Development (GBED) is excited to announce the launch of its BC ReNew - Housing Rehab Program in Great Bend, Ellinwood, Hoisington, and Claflin. This program aims to provide homeowners

in these areas with an opportunity to upgrade their older homes while receiving a rebate grant of up to 10% for material purchases.

Under the program, eligible homeowners who occupy their

properties within the city limits may qualify for a rebate grant based on the cost of their rehabilitation project. The rebate is determined as follows:

- 8.7% of material purchases if less than 90% of the materials are locally purchased, provided the material costs exceed \$10,000 per approved project.
- 10.0% of material purchases if over 90% of the materials are locally purchased, provided the material costs exceed \$10,000 per approved project.

The maximum award per recipient is set at \$10,000. Homeowners and contractors must demonstrate their experience in property rehabilitation or present a plan that utilizes contracted resources to carry out the rehabilitation process.

The application process involves homeowners submitting a complete application with all the required documents to the GBED office for review by the Housing Rehab Committee. The committee will then approve or reject the

application and inform the homeowner accordingly. Documentation, including before and after photos, will be required for verification purposes.

The Housing Rehab Committee, in conjunction with the GBED

Board, will review all

program applications and make

recommendations for approval.

Ongoing rehab projects will also be monitored by the committee to

provide guidance and


support to owners and contractors. For the year 2023, a total of \$35,000 has been allocated to this program.

BC RENEW

Eligible upgrades under the BC ReNEW Housing Rehab Program include structural improvements, energy conservation measures, and modernization projects.

BC ReNEW is committed to revitalizing the community and enhancing the quality of housing in Great Bend, Ellinwood, Hoisington, and Claflin. This program presents a unique opportunity for homeowners to improve their homes while receiving financial assistance.




