# Meyers Enterprises

### Tell us about you and your business:

My business is an advertising agency. We specialize in digital media: customer and talent acquisition through channels like Paid Search, Paid Social, and Display.

Here's an example: imagine you have a business selling products on your website and you make an average profit of \$50 per customer; so you know that you need to get new customers for less than \$50 a piece, and you'd like to scale your business from 100 customers per month to 300 customers per month. This would make you our ideal customer. We can use Paid Search, Display, and Social Media to drive new customers to your website, and we can measure our results to ensure that we are driving customers at a cost of less than \$50 each so that you remain profitable.

Another good example would be if you own a manufacturing

company and you're constantly in need of new employees. Also imagine that you have specialized needs for employees that you'll need to convince to relocate to Barton County, say CAD designers. We can use Display, Paid Search, and Indeed advertising in order to recruit these employees both locally and from afar.

My agency generally operates at large scale that is our competitive advantage versus other agencies. We're looking more for clients who can spend a few thousand dollars a month on digital media at minimum, and we have the capacity to deliver world-class results for budgets over a million dollars a month.

I don't view my agency as strictly a business. We are an advertising center of excellence in an academic sense. We're a research institution as much as we are an agency. Come in if you have a question about advertising or want to talk about advertising. We love to talk about the industry even if you aren't, and won't be, a paying customer.

# Why did you choose to locate your business in Barton County?

Hoisington is my hometown.

My business's motto is "expect to win." That is our North Star, and it's the lens through which we evaluate every decision we make.

# Why do you like to do business in Barton County?

Barton County is free economically and logistically. When I want fix something in my building, I can just fix it without going through layers of regulatory red tape. Our county's regulators use common sense in that regard, which is a huge plus.

For my business in particular, that part is very important. Although we'd be more than glad to do business with anyone in Barton County, and we'd deliver a true "hometown" level of service, I understand that we'll most likely need to expand outside Barton County and outside the state of Kansas even to really make ends meet

as an advertising agency. So for me, the favorable operating conditions of Barton County as a home base are key.

And the people here that I would be using as my employee base are people that I relate to and that I believe in. Really that's the most important part. I believe in the people here. Period. The end.

### What inspired you to start your business?

Starting my own business is something I've wanted to do since I was a little kid. I don't know why, really. It's always just felt like God's plan.

I'd like to use my business to promote the local community, especially here in Hoisington. I want to help grow our pool of white collar, office-type job openings. And more than that, I want to expand the number of jobs that can be 7-7, not just 9-5. (I'm not saying that all of my people have to work 12 hours a day, lol). I want there to be more options where people can choose to take a 'bigger bite of the apple' if they want to. I want people to not feel like they need to move to Kansas City if they want to 'really be serious' about growing their career. I want that available here too.

Also, this would be a good place to note the inspiration for my business's name. The structure [Last Name] Enterprises is a





reference to I C Walter Enterprises. Anyone who's from Hoisington would understand why you would name your startup after Ike's business. It doesn't sound like an advertising agency's name, but oh well.



# Governor 'digs in' to childcare in Barton County

The Kansas Children's Cabinet and Trust Fund has announced that Advancing Barton County Childcare (ABCC) proudly ranks in the elite top 4 awards for Kansas communities, and will receive a substantial grant of \$2,238,630. This remarkable achievement propels ABCC's mission to establish affordable and accessible childcare facilities within Barton County. Governor Laura Kelly, the keynote speaker at the groundbreaking ceremony in Great Bend, spoke about the importance of quality childcare and its effect on Kansas' workforce.

ABCC's aims to address the escalating demand for childcare capacity within our community, while also catering to the workforce needs of the region. Spearheaded by Great Bend Economic Development (GBED), ABCC has assumed the crucial responsibility of securing funding and constructing cutting-edge group daycare centers in Barton County. With the pressing demand for reliable and accessible childcare services in mind, this significant grant will propel ABCC forward in realizing their vision of establishing the first two premier daycare centers in Barton County.

The first facility, which will be located at Farmer's Plaza on the corner of 10th Street and K-96 Highway, is now fully funded, thanks to this substantial grant.

ABCC marked the milestone with a groundbreaking ceremony on July 20th.

ABCC unveiled the next facility is slated for Hoisington, and the site director, Kelsie Baxter, has been hired. (More on Page 11)




