

# Properly Plated, Perfectly Planted

How a KU grad turned her creative passion into a thriving charcuterie business—and found unexpected joy in coming home

#### Tell us about yourself and your business.

I was born and raised in Great Bend, graduated from the University of Kansas (Rock Chalk!), and then lived in Kansas City for 6 years before moving back to GB in November of 2022. I've loved living in Great Bend as an adult much more

than I expected. I live with my partner, Hunter, and our three dogs, Basil, Benji and Bentley, otherwise known as the 3Bs! Hunter and I both love to go on road trips and travel in general. Hunter moved to Great Bend from Salina in March of 2024 and is currently a student out at Barton in the Natural Gas program.

I have a full time job where I work from home as a Senior Implementation Specialist at a restaurant software company called Olo. It is very fulfilling because I love working with different restaurants and their corporate teams to launch software solutions that make their operations easier and their businesses more successful. I am a busy body at my core and I love having a social life and being part of a community so it was important that I find something to fill some of my free time. The two main components missing from my career are in-person social activities and hands-on work, both of which I easily fulfill with Proper Boards & Picnics! In my spare time outside of my work with Olo and with Proper I enjoy crafting, reading, and spending time with my family and friends.

Proper Boards & Picnics is a charcuterie board & grazing table business. Along with the boards and grazes I host workshops to teach people how to build their own charcuterie boards, how to pair food together, and how to pair food with wine, coffee, beer, or any other drink. I love bringing a variety of delicious and fresh food to the community and encouraging people to get creative with their taste buds! (Especially that mustard, am I right? If you know, you know!

The business model is closer to a catering business than anything else so I don't have specific hours, you can always reach out to me and I'll get back to you (please be patient, I am largely a one woman show so I can get a little backed up on work sometimes!)

the occasional function for a long time because it was something that was fun for me to put together. I love good food, I love color and creativity, and I needed an opportunity to be more involved with the community all of which made the pursuit of Proper Boards feel very natural and fun. It brings me a lot of happiness to create joy for other people so Proper is really designed around just that: creating joy.

# Why did you choose Barton County for your business?

The overwhelming community support and pride others take in living and owning a business in Barton County. Family, friends, acquaintances, the Chamber(s), Economic Development, and even strangers are rooting for your success and that feels so amazing.

# Why do you enjoy doing business in Barton County?

The people, the support, the genuine interest and appreciation people have for me and the business.

#### What inspired you to start

#### your business?

A wide variety of things like (but not limited to) wanting to create joy for others, needing to be involved in the community, and a hunger for expressing creativity with color and delicious food (pun intended).

# What did your startup plan and timeline look like?

I soft launched in summer of 2023 and more officially launched in January of 2024. It was important to me that I tested the market to understand if the people of Great Bend would find value in a charcuterie board business and now that I'm a year or so into it, boy does that feel like a silly question to have even asked! For the first 8 months of being in business, I was driving to Bushton, KS (about 30 minutes northeast) to work out of an incubator kitchen in their community building. There was a lot of driving, packing, unpacking, sorting, and planning to make sure everything was at the right place at the right time especially given that the majority of my



business was being done in Great Bend. I am incredibly grateful to the Bushton community for that space because without it Proper would not have been able to get off the ground. Thankfully I was able to get in touch with the My Town team and began renting the Tellers kitchen in September of 2024! I have loved running Proper out of that kitchen in downtown Great Bend, especially with an iced vanilla latte so close. I have plans to continue expanding Proper with more food options and my own space eventually.

# What advice would you give to businesses considering Barton County?

That the community support is overwhelming in the best way. Getting connected with GB Ec Dev and also the Chamber of Commerce will catapult your business into something you only dreamed of!

Do you have any advice for entrepreneurs starting out? It's going to take every ounce of perseverance you have but it's incredibly rewarding. Also don't forget that self-care is important, make sure you still have time for the things that matter most in your life.

# What obstacles have you faced and how did you overcome them?

Finding a place for Proper to live was the most difficult, ideally I wouldn't have had to drive to Bushton to make Proper a reality. That took a lot of perseverance and motivation. Another obstacle I've faced is more internal as I can often succumb to thoughts that I'm not doing enough. I frequently have to remind myself that what I am doing is enough and that I don't need to take on more at every given turn, that it is okay to go through periods that are not focused on hypergrowth. I'm a people person and I'm so blessed to be able to serve in this community. Meeting and conversing with my customers is the highlight of my days!

the chance to pitch their business ideas, connect with entrepreneurial leaders, and compete for cash prizes.


Representing Barton County, The Kansas Voice and Ice on Wheels showcased their creativity and professionalism on the tradeshow floor—impressing both the public and judges.

Great Bend Economic Development is excited to announce the return of Network Kansas 75% tax credits—a powerful opportunity for individuals and businesses to support local entrepreneurship while enjoying significant tax savings.

Here's how it works: When you purchase Network Kansas tax credits, you receive a 75% credit on your Kansas state income taxes. That means a \$1,000 contribution would reduce your state tax liability by \$750 leaving a net cost of just \$250.

But the impact goes even further. 30% of every dollar raised through these tax credits comes directly back to Great Bend Economic Development to fund programs that support entrepreneurs and small businesses in our community. Whether it's training, technical assistance, or early-stage funding, these dollars help build a stronger local economy.

These tax credits are limited and available on a first-come, first-served

basis. If vou're looking for a meaningful way to invest in the future of Great Bend while reducing your state tax bill, now is the time to act.

#### **Entrepreneurship Tax Credits**

#### **Program Overview**

The Kansas Economic Growth Act of 2004 established the Center for Entrepreneurship (d.b.a. Network Kansas) to build an entrepreneurial ecosystem connecting resource organizations and entrepreneurs. A key initiative was providing seed capital to small businesses in rural and distressed areas, supported by the Kansas Center for Entrepreneurship Tax Credit.

Additional program details:

- A tax credit is a dollar-for-dollar credit against income tax liability
- For every \$1,000 donated, donors will receive \$750 credit directly off of their income tax liability Donors may be eligible to receive a federal and state tax deduction and should consult with their individual tax specialist to determine the amount of any deductions. A K-31 Form is required with the individual tax form and is available online through the Kansas Department of Revenue
- Minimum and maximum allocations are based per tax ID number (EIN, SSN)
- Individuals, financial institutions (i.e., banks, savings & loans), and corporations can donate Lending institutions may apply CRA credits

Minimum allowable tax credit per year \$250 Donation = \$187.50 Tax Credit \$133,333.33 Donation = \$100,000 Tax Credit

#### Donate

Donations fund entrepreneurship programs and matching loans via Network Kansas' partners, including local/regional organizations, agencies, small business development centers, and others aiding entrepreneurs and small businesses in Kansas.

Contact the Network Kansas Business Development Department (below) for more information regarding criteria for participation and to verify that tax credits are available. Donors will be required to provide identification to receive credit for their donation. Deadline to submit payment is November 1st. Make checks payable to the Kansas Center for Entrepreneurship. **Art & Wine Walk** – Don't miss a stop on the Wine Walk with the help of this tour.


Each stop includes photos, audio narration, videos, and artist interviews—plus GPS integration to guide you from one highlight to the next at your own pace.


